The candidates eligibility for “on the Spot Admission” is as follows,

- Candidates should have applied for M.Tech. Programme at IIT Bombay for the academic year 2022-23.
- Candidates should NOT have “accepted” his/her offer in COAP. However, candidates/students who have already confirmed the admission/ joined IIT Bombay may appear for ‘on the spot admission’ for “change of specialisation” within the department. Moreover, candidates who have accepted the offers at IIT Bombay are not eligible for **inter-department movement/shift**.
- The candidates should give an “Undertaking” that they have not accepted the offers on COAP in the format specified.

The procedure to be followed is as follows:

- Report at **LA-201 at 08:30 a.m**
- To attend in person/physical mode : The candidates are required to be present in person and no representatives of the candidates will be permitted to participate in the admissions procedure. **No accommodation and travel allowances are given for attending this spot admission.**
- A consolidated merit list will be put up on the same day (_____).

4. Those selected will be required to submit a declaration confirming the acceptance of the seat and need to pay the fees directly to the following account.

After payment candidates need to communicate the transaction details (UTR number) to the concerned academic units for their confirmation of admission at IIT Bombay.

If you have opted for Hostel Accommodation then you are required to submit the Mess Advance of Rs. 27,000/- by ONLINE payment /Net Banking as per the link provided in the online admission portal. The candidate shall directly contact The Assistant Registrar, Hostel Co-ordinating Unit(HCU), Ground Floor, Main Building, IIT Bombay on 022-25768900/8901 or email at arhcu@iitb.ac.in / hcu.office@iitb.ac.in, for all hostel related queries. Please note that the Institute provides accommodation on campus strictly for the stipulated duration of Programme under which one is admitted.

Hostel accommodation will be extended to FA/TA/RA/TAP/RAP/SF (Monash) category students of all PG programmes. However, please note that due to the extreme paucity of hostel rooms at IIT Bombay the initial two years of accommodation will be in double occupancy.

5. Those candidates wishing to cancel/withdraw admission after paying the requisite fees **MUST** communicate the same by an email given in the application form to pgadm@iitb.ac.in stating subject“ **CANCELLATION OF SPOT ADMISSION**)” by specifying the department/specialization and application ID.

E-mail regarding cancellation/withdrawal of admission will be entertained, **ONLY IF**, the request is made through E-mail ID given in the Application form.

In such cases, cancellation/withdrawal, **only refundable deposits** will be refunded. The refund will be sent to the respective candidate's Bank account (through which they have debited/paid the admission fees) by NEFT within ONE month time from receipt of such e-mail/ request, after verifying the details.
