SECTION 2: INSTRUCTIONS TO BIDDERS

1	PREPARATION AND SUBMISSION OF OFFER
1.1	Vendor Registration is MANDATORY. Vendors are requested to register themselves as VENDOR of IITB by visiting the following link and generating a USER ID & PASSWORD: IIT Bombay Vendor Registration Portal Help for Vendor Registration: Registration Flow Chart
1.2	The bid as well as all the correspondence and documents related to the bid, the bid exchanged between the bidder and IIT Bombay shall be in English Language.
1.3	In the case of a Single-Bid System, bidders are required to submit their offers as follows: • The Single bid (both Technical & Financial bid in single envelop) system has to be followed for this tender. • Tender should be submitted within the schedule date of the tender in the sealed cover super scribed with 'Tender Number' Description and Due Date and to be submitted to the concern department/section mentioned in tender document. • The financial quotation should be submitted strictly as per the given format (Section – 7). • Contract/ Purchase Order will be awarded to the lowest bidder(L1). Please ensure that envelope is properly labeled with tender details to avoid any confusion during the evaluation process.
1.4	The bids must be submitted in a sealed envelope clearly super scribed with Tender number and due date . The quotation should reach the tender submission address on or before the due date and time mentioned in the tender notice. Unsealed quotations will be rejected.
1.5	Bids should be dropped in the tender box kept in the office of the concerned Department / Section. Bids should not be handed over to any staff personally unless otherwise specified. All communications are to be addressed to the undersigned only. In case the due date happens to be a holiday the bids will be accepted and opened on the next working day.
1.6	The bid can be submitted in person or through post/ courier (IIT Bombay is not responsible for postal delays or any issue causing late submission) so as to reach on or before the due date and time specified in the tender document. Bids received after the deadline shall be rejected.

1.7	It is mandatory for Indian subsidiaries, agents and Indigenous bidders to have a valid GSTN Registration Number and should submit duly filled Bidders Information along with the tender document as per Annexure - I .
1.8	Bidders should duly filled 'Questionnaire' as per Annexure - II and submit the same along with the technical bid.
1.9	Indian Agents and OEMs:
1.9.1	All Indian Agents must submit a copy of the Indian Agent Agreement / Authorization letter from OEM / OEMs along with the tender as per Annexure - III
1.9.2	In a tender, either the Indian agent on behalf of the Principal / OEM or the Principal / OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. In case, offers are received from manufacturers and their authorized agents, offers from their manufacturers only shall be considered.
1.9.3	If an agent submits a bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same bid for the same item/product.
1.10	If the warranty is not specifically mentioned in the Technical Specification by the bidder then the warranty will be assumed as One year from the date of successful installation/commissioning of equipment.
1.11	Regarding the Import supplies, in case of FOB/FCA the bidder must mention the 'Nearest International Airport/ Port of Shipment' .
1.12	It is mandatory for the bidders to specify the delivery period.
1.13	IIT Bombay discourages procurement through High Sea Sale. Such bids may be rejected.
1.14	Bid responses through any mode other than those specified in the RFQ document will not be considered.

1.15	To establish the conformity of the goods and services to the specifications and schedule of requirements of the bidding document, the documentary evidence of conformity of the goods and services to the bidding documents may be in the form of literature, drawings and data, catalogue, brochure to be enclosed in Technical bid and shall consist of: A detailed description of the essential technical and performance characteristics of the goods; A list giving full particulars, including available sources, spare parts, special tools, etc., necessary for the proper and continuous functioning of the goods; and An item-by-item commentary on the Purchaser's Technical Specifications demonstrating substantial responsiveness of the goods and services to those specifications.
2.	COST OF BIDDING
2.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid and the IIT Bombay shall not be responsible or liable for those costs regardless of the conduct or outcome of the bidding process.
3.	VALIDITY OF THE OFFER
3.1	The bid shall remain valid for a period of 180 days from the last date of submission of the bid. During this period, the bidder shall not be permitted to modify, withdraw or revoke the bid. IIT Bombay reserves the right to reject any bid that is not valid for the specified duration.
4.	AMENDMENT OF BIDDING DOCUMENTS
4.1	At any time before the deadline for submission of bids, IIT Bombay may, for any reason, whether on its own initiative or in response to the clarification requested by a prospective BIDDER; modify the bid document.
4.2	All prospective BIDDERS, who have downloaded the tender document are advised to regularly check the IIT Bombay website for updates, amendments or modifications. These changes will be legally binding on all bidders.
4.3	Any extension of the due date or other changes related to the tender will be notified only online through the following official websites: https://www.iitb.ac.in/resources/vendors-tenders https://eprocure.gov.in/epublish/app No separate publication will be made in newspapers. Bidders are advised to regularly check the above websites for updates.

5.	MODIFICATION OF BIDS
5.1	A bidder who wishes to modify their original offer or terms may submit a revised or supplementary offer within the extended Tender Opening Date. The revised submission must clearly specify the extent of modifications or updates made to the original offer. IIT Bombay reserves the right to open and consider the original offer along with the revised offer, for the purpose of evaluation.
6.	DEADLINE FOR SUBMISSION OF BIDS
6.1	Timely submission of the bids is the responsibility of the bidders. Bids must be received at IIT Bombay before the due date and time on the address specified in the tender document. In the event of the specified date for the submission of bids being declared as a holiday for IIT Bombay the bid-closing deadline will stand extended to the next working day up to the same time without any further notice.
7.	LATE BIDS
	IIT Bombay shall not be responsible for the following: • Delayed or late submission of quotations sent via post, courier or any other means. • Submission/delivery of bids to the wrong location other than the address or location specified in the tender document. • Any bid received after the deadline (i.e., after the specified due date and time) will be rejected without exception. Such bids will be returned unopened to the bidder by hand, speed post or courier, without any prejudice.
8.	EXTENSION OF BID SUBMISSION DATE
8.1	No request for an extension of the tender due date will be entertained unless necessitated due to changes in the specifications or non-receipt of the minimum number of responses. IITB reserves the right to extend the tender due date for any other reason it may deem fit.
9.	BID OPENING PROCESS

9.1	In case of one bid system, technical & financial bids will be opened simultaneously in the presence of the purchase committee and representatives of the bidders at IIT Bombay.
9.2	In case of two bid systems, the Technical Bid will be opened in the first instance in the presence of the Technical Evaluation Committee and representatives of the bidders. The Financial Bids will be opened only for those bidders whose Technical Bids are found to be technically qualified by the Technical Evaluation Committee. The opening of Financial Bids will be conducted in the presence of the Technical Evaluation Committee and representatives of the qualified vendors, at a later date. The Date and Time for the financial bid opening will be intimated only to the technically qualified bidders.
9.3	One authorised representative from each bidder shall be permitted to attend the bid opening session. Representatives must present a valid Authorisation Letter issued by their respective organizations in order to participate in the meeting. All authorised representatives present during the opening of the Technical or Financial Bids will be required to sign an Attendance Register as proof of their participation in the respective session.
10.	EVALUATION
10.1	All the bids shall be evaluated based on the final landed cost at IIT Bombay which includes all applicable taxes, duties and other charges. For imported items, the costs of freight, customs duty, insurance along with applicable Integrated Goods and Service Tax (IGST) will be considered for comparison. If different GST rates are quoted by bidders for the same item, IIT Bombay will apply the HSN Code and GST norms of the Government of India to ensure uniform comparison across all bids.
10.2	IIT Bombay shall compare all substantially responsive bids to determine the lowest evaluated bid. The Institute is following and abiding with the revised Public Procurement (Preference to Make in India), Order 2017 P- 45021/2/2017-PP (BE-II)-Part(4)Vol.II dated 19.07.2024 issued by DPIIT, Ministry of Commerce and Industry, Govt. of India & subsequent instructions of the Ministry. Accordingly, preference will be given to the Make-in-India products while evaluating the bids. However, it is the sole responsibility of the bidder(s) to specify the product quoted by them is of Make in India along with respective documentary evidence in the technical bid itself. Declaration as per Annexure - IV .
10.3	Price preference to Local suppliers as per the orders of Make in India procurement policy of Govt of India and MSEs shall be given as per provisions and methodology specified in the Orders.

11	NON-CONFORMITY, ERROR, AND OMISSION
11.1	IIT Bombay may request that the Bidder submit the necessary information or documentation, within a reasonable period, to rectify non-material non-conformities or omissions in the bid related to documentation requirements. Such omission shall not be related to any aspect of the price of the Bid. Failure of the Bidder to comply with the request may result in the rejection of its Bid.
11.2	IIT Bombay may request the bidder to clarify the arithmetic errors if any during the evaluation of commercial bid within a target date. In case, no reply is received within the stipulated date IIT Bombay reserves the right to evaluate the said bid with the available information or summarily reject the bid.
12	PRICE BID
12A	For Foreign Bidder:
12A.1	The Price should be quoted net of discount and exclusive of taxes by the bidders. It is mandatory to mention INCOTERM along with the quote in the price bid.
12A.2	IIT Bombay reserves the right to increase or decrease the ordered quantity to an extent of 25% (maximum) till the finalization of the contract or issue of purchase order, by giving reasonable notice to the successful bidder.
12A.3	IGST will be applicable for imported goods. Relevant tax code as per the applicable slab of GST has to be selected by the bidder. If the bidder selects the wrong tax code while bidding then IIT Bombay shall correct it as per GOI norms/HSN code and uniform tax will be applicable as per HSN code of the product for all the bidders.
12A.4	As per Govt. of India Notification No. 51/96 Customs dtd. 23rd July 1996, (Substituted under Notification No.43/2017 dtd. 30th June 2017) Concessional Customs Duty is applicable to IIT Bombay for all purchases which are essential for research. IIT Bombay shall provide all the documents under this notification to the bidder to facilitate clearance of the goods. The bidder has to specifically mention in the bid the requirement of the certification.
12B	For Indigenous Bidder:
12B.1	Prices should be quoted net of discount and exclusive of taxes by the bidders. The price quoted should be in Indian Rupees, with free delivery at IIT Bombay Campus at the site (DDP).

12B.2	IIT Bombay reserves the right to increase or decrease the ordered quantity to an extent of 25% (maximum) till the finalization of the contract or issue of purchase order, by giving reasonable notice to the successful bidder.
12B.3	GST is applicable for all purchases to IIT Bombay. Relevant tax code as per the applicable slab of GST has to be selected by the bidder for Indigenous items. (If a bidder selects the wrong tax code while bidding then IIT Bombay shall correct it as per GOI norms/HSN code and uniform tax will be applicable as per the HSN code of the product for all the bidders uniformly).
12B.4	The supplier shall pay and bear all other liabilities, taxes and duties not specifically agreed upon by IIT Bombay in the contract. Concessional Custom Duty Exemption Certificate (CDEC) will not be provided against Indigenous Supplies.
13.	CANCELLATION OF TENDER
13.1	Notwithstanding anything specified in this bidding document, Purchaser / IIT Bombay at its sole discretion, unconditionally and without assigning any reason, reserves the right: • To accept OR reject the lowest bid or any other bid or all the bids. • To accept any bid in full or in part. • To reject the bid offer not confirming the tender's terms. • To reject the bid, if the prices received are abnormally low or unreasonably high. • To give purchase preference to Public Sector undertakings when applicable as per Govt. Policy/ Guidelines.
13.2	The bids submitted by vendors which are conditional in nature will be summarily rejected.
14.	BID SECURITY
14.1	Bidders must furnish Bid Securing Declaration in lieu of Bid Security / EMD. The Bid Security Declaration has to be furnished as per Annexure - V along with Technical Bid. A self-attested scan copy of the declaration should be uploaded along with bids. Bids not complying with these provisions shall be rejected.
15.	PERFORMANCE GUARANTEE
15.1	Performance Guarantee is mandatory.

15.2	Successful tenderer/ bidder should submit a performance guarantee as prescribed under clause 15.3. The performance guarantee is to be furnished in the form of a bank guarantee as per Format 1 , for an amount covering 3% of the purchase order value.
15.3	The Performance Guarantee should be established in favour of “The Registrar, IIT Bombay”.
15.4	Performance Guarantee is to be established through any of the National/ Scheduled Commercial Banks (whether situated at Mumbai or outstation) with a clause to enforce the same on their local branch of Mumbai. The hard copy of Performance Guarantee has to be submitted to Deputy Registrar , Materials Management Division, IIT Bombay along with order acknowledgment.
15.5	Performance Guarantee shall be for the due and faithful performance of the contract and shall remain binding, notwithstanding such variations, alterations for extensions of time as may be made, given, conceded or agreed to between the successful tenderer and the purchaser under the terms & conditions of acceptance to the tender.
15.6	Performance guarantee shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations, commencing from the date of commissioning / installation of goods. In case of services, the guarantee should be valid till sixty days beyond the duration of service period / contractual obligations. For procurement above INR 1 Crore, where integrity pact is applicable, the performance guarantee shall be for a minimum duration of two years as per the provision of integrity pact or till the warranty / contract period whichever is later. In case Performance Guarantee needs extensions up to the warranty period then the supplier shall initiate extensions to Performance Guarantee one month before the expiry of Performance Guarantee.
15.7	If the successful bidder fails to submit the Performance Guarantee along with Order Acknowledgement then the purchase order/contract will be canceled.
15.8	No interest shall be payable by the buyer to the Bidder on Performance Guarantee.
16.	FURNISHING FRAUDULENT INFORMATION/ DOCUMENT

16.1	If it is found that a bidder has furnished fraudulent document/information, the bid security/performance security (wherever applicable) shall be forfeited and the bidder/vendor will be debarred for a period of upto 2 (two) years from the date of detection of such fraudulent activity, besides the legal action. In case of major and serious fraud, the period of debarment may be enhanced.
17.	CONFIDENTIAL INFORMATION
17.1.	The bidder/seller shall treat as confidential all designs, drawings, data or information written or verbal, provided by IITB and shall use its best endeavors to ensure that such design, drawings, data or information is not divulged to any third party except with the consent of IITB where necessary for the performance of its obligation hereunder and subject to similar undertakings being obtained from such third parties to treat such design, drawings, data or information in confidence.
18.	REASONABILITY OF PRICE
18.1	The price quoted shall be the best competitive/minimum price applicable for a premier Educational and Research Institution. The bidder may be required to give details of at least two purchase orders of identical or similar equipment, supplied to any IIT's/Research Institutions/ other organizations as and when required as per Format 2 (to be enclosed in the technical bid) along with the final price paid and details.
19	INSTRUCTIONS TO THE BIDDERS OF COUNTRIES WHICH SHARE LAND BORDER WITH INDIA
19.1	Any bidder from a country which shares a land border with India will be eligible to bid on this tender only if the bidder is registered with the Department for Promotion of Industry and Internal Trade (DPIIT). Compliance as per Annexure - VI.
19.2	"Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated herein before, including any agency branch or office controlled by such person, participating in a procurement process.

19.3	"Bidder from a country which shares a land border with India" means: - a. An entity incorporated, established, or registered in such a country; or b. A subsidiary of an entity incorporated, established, or registered in such a country; or c. An entity substantially controlled through entities incorporated, established, or registered in such a country; or d. An entity whose beneficial owner is situated in such a country; or e. An Indian (or other) agent of such an entity; or f. A natural person who is a citizen of such a country; or g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
19.4	The beneficial owner for point no. 19.3.d above will be as under:
19.4.1	In the case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together or through one or more juridical persons, has a controlling ownership interest or who exercises control through other means. Explanation- "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of shares or capital or profits of the company. "Control" shall include the right to appoint a majority of the directors or to control the management or policy decisions including by their shareholding or management rights or shareholders agreements or voting agreements.
19.4.2	In the case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together or through one or more juridical persons, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
19.4.3	In the case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together or through one or more juridical persons, has ownership of or entitlement to more than fifteen per cent of the property or capital or profits of such association or body of individuals;
19.4.4	Where no natural person is identified under point no. 19.4.1 or 19.4.2 or 19.4.3, the beneficial owner is the relevant natural person who holds the position of senior managing official.

19.4.5	In the case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen per cent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
19.5	An Agent is a person employed to do any act for another or to represent another in dealings with a third person.
19.6	In the case of tenders for Works contracts, including Turnkey contracts, the successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority.
20.	DEVIATION, RESERVATIONS AND OMISSIONS
20.1	During the evaluation of bids, the following definitions apply: • "Deviation" refers to a departure from the requirements specified in the Bidding Documents. • "Reservation" refers to the setting of limiting conditions or withholding complete acceptance of the requirements specified in the Bidding Documents. • "Omission" refers to the failure to submit part or all of the information or documentation required in the Bidding Documents.

SECTION 3: CONDITIONS OF CONTRACT

1.	AWARD OF CONTRACT
1.1	Subject to clauses 10.2 & 10.3 of section 2, IIT Bombay shall award the contract to the technically qualified eligible BIDDER whose bid has been determined as the lowest evaluated commercial bid.
1.2	If more than one BIDDER happens to quote the same lowest price, IIT Bombay reserves the right to award the contract to more than one BIDDER or any BIDDER.
2.	DUTIES AND TAXES
2.1	Duties and taxes shall be applicable and included in the contract as per the provisions of Clause No.12A & 12B of RFQ under Section 2. The supplier shall pay and bear all other liabilities, taxes and duties not specifically agreed upon by the Purchaser in the contract.
3.	PRE- INSTALLATION
3.1	The bidder has to mention the pre-installation requirements for the equipment like ambient temperature, humidity, civil work, weather specifications, power specifications, etc.
4.	INSTALLATION
4.1	BIDDER shall be responsible for installation/demonstration wherever applicable and after-sales service during the warranty period and thereafter as mentioned in the contract.
4.2	Installation demonstration is to be arranged by the supplier free of cost. The installation and demonstration have to be done within 15 days of the arrival of the equipment at the site and performance satisfaction should be ascertained.

5.	TRAINING
5.1	The BIDDER should provide training for the operation and maintenance to the personnel of IIT Bombay on the offered equipment/machinery.
5.2	Wherever needed, our technical persons should be trained by the supplier at the project site. In case the person is to be trained at the supplier's site abroad or in India it should be mentioned in the quotation. The supplier should bear all the expenses for such training including 'to & fro' fares and lodging & boarding charges.
6.	TERMS OF PAYMENT
6A	For Foreign Order:
6A.1	100% Payment by Letter of Credit (90% payment will be released on receipt of documents without any discrepancies and the balance 10% will be paid after satisfactory installation and commissioning). OR Payment via wire transfer within 30 days after delivery and acceptance of material.
6A.2	In case of AMC / CAMC "Payment on six monthly bases in equal installments subject to certification of satisfactory performance by Indentor/User."
6A.3	Any request for a change in payment terms will not be entertained after the release of Purchase Order.
6B	For Indigenous Order:
6B.1	For Equipment/Goods "Payment within 30 days from the date of delivery, installation and Acceptance Certificate of concerned Department / Section IIT Bombay."

6B.2	In case of AMC / CAMC “Payment on six monthly bases in equal installments subject to certification of satisfactory performance by Indentor/User.”
6B.3	Payment shall be made by NEFT/ RTGS or such other mode / electronic fund transfer offered by the Bank.
6B.4	IIT Bombay does not make advance payments to suppliers.
7.	LEGAL MATTER
7.1	All disputes, whether domestic or international, arising out of or in connection with this tender or any subsequent contract shall be subject to the exclusive jurisdiction of the courts in Mumbai, India. Such disputes shall be governed and adjudicated in accordance with the laws of India.
8.	TRANSFER AND SUBLETTING
8.1	The bidder shall not sublet, transfer, assign or otherwise part with the acceptance to the tender or any part thereof, either directly or indirectly, without the prior written permission of the Purchaser i.e. IIT Bombay.
9.	FORCE MAJEURE

Unless otherwise directed by the Procuring Entity in writing, the contractor shall continue to perform its obligations under the contract as far as reasonably practicable and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

12.	SUPERVISION OF ERECTION AND COMMISSIONING

This pre-bid pre-contract Agreement hereinafter called the Integrity Pact is made on day of the month of, between, on one hand, the Director of IIT Bombay acting through Deputy Registrar, Materials Management Division of Indian Institute of Technology Bombay hereinafter called the “BUYER” of the First Part and M/s..... represented by Shri....., Director /Chief Executive Officer/ General Manager hereinafter called the “BIDDER/Seller” of the Second Part.

WHEREAS the BUYER proposes to procure..... (Name of the Stores/Equipment/Item) and the BIDDER/Seller is willing to offer/has offered the stores and WHEREAS the BIDDER is a private company/public company/Government undertaking/partnership/registered export agency, constituted in accordance with the relevant law in the matter and the BUYER is an Autonomous Body/Department of the Government of India performing its functions on behalf of the President of India.

NOW, THEREFORE, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to :-Enabling the BUYER to obtain the desired said stores / equipment at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and Enabling BIDDERS to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the BUYER will commit to prevent corruption, in any form, by its officials by following transparent procedures. The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

1. Commitments of the BUYER

1.1 The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the Contract.

1.2 The BUYER will, during the pre-contract stage, treat all BIDDERS alike, and will provide to all BIDDERS the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS.

1.3 All the officials of the Buyer will report to the appropriate authority of the Institute for any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

2. In case any such preceding misconduct on the part of such official (s) is reported by the BIDDER to the BUYER, with full and verifiable facts and the same is prima facie found to be correct by the BUYER, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the BUYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the BUYER the proceedings under the contract would not be stalled.

3. Commitments of BIDDERS:

3.The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following:

3.1 The BIDDER will not offer, directly or through intermediaries, any bribe, consideration, gift, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the

BUYER, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract.

3.2 The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the BUYER or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the Contract or any other Contract with the Government for showing or for bearing to show favour or disfavour to any person in relation to the Contract or any other Contract with the Government.

3.3 BIDDERS shall disclose the name and address of agents and representatives and Indian BIDDERS shall disclose their foreign principals or associates.

3.4 BIDDERS shall disclose the payments to be made by them to agents / brokers or any other intermediary, in connection with this bid/contract.

3.5 The BIDDER further confirms and declares to the BUYER that the BIDDER is the original manufacturer/ integrator/ authorized government sponsored export entity of the defense stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the BUYER, or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.

3.6 The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the BUYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.

3.7 The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

3.8 The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.

3.9 The BIDDER shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the BUYER as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.

3.10 The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.

3.11 The BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.

3.12 If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, either directly or indirectly, is a relative of any of the officers of the BUYER, or alternatively, if any relative of an officer of the BUYER has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filing of tender. The term relative for this purpose would be as defined in Section 6 of the Companies Act 1956.

3.13 The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the BUYER.

4. Previous Transgression:

4.1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India, that could justify BIDDER's

exclusion from the tender process.

4.2 The BIDDER agrees that if it makes an incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such a reason.

5. Security Deposit / Performance Guarantee:

5.1 Performance Guarantee Bond is mandatory.

5.2 Successful tenderer/ bidder should submit performance guarantee as prescribed above to be sent to Deputy Registrar, Materials management Division, IIT Bombay on or before 15 days from the due date of issue of order acknowledgement. The PBG to be furnished in the form of bank guarantee as per proforma or annexure of the tender documents, for an amount covering 3 % of the purchase order value.

5.3 The Performance Guarantee should be established in favour of "The Registrar, IIT Bombay".

5.4 PBG to be established through any of the National Banks (whether situated at Mumbai or outstation) with a clause to enforce the same on their local branch of Mumbai or any scheduled bank (other than national bank) situated at Mumbai. Bonds issued by cooperative banks will not be accepted.

5.5 Performance Guarantee Bond shall be for the due and faithfully performance of the contract and shall remain binding, notwithstanding such variations, alterations for extensions of time as may be made, given, conceded or agreed to between the successful tenderer and the purchaser under the terms & conditions of acceptance to the tender.

6. Sanctions for Violations:

6.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the following actions, wherever required: -

i. To immediately call off the pre-contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.

ii. The Earnest Money Deposit (in pre-contract stage) and/or Security Deposit/Performance Bond (after the contract is signed) shall stand forfeited either fully or partially, as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.

iii. To immediately cancel the contract, if already signed without giving any compensation to the BIDDER.

iv. To recover all sums already paid by the BUYER, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the BUYER in connection with any other contract for any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.

v. To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.

vi. To cancel all or any other Contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any

ix. In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the BUYER with the BIDDER, the same shall not be opened.

x. Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.

6.2 The BUYER will be entitled to take all or any of the actions mentioned at para 7.1(i) to (x) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act 1988 or any other statute enacted for prevention of corruption.

6.3 The decision of the BUYER to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the CVO, IIT Bombay appointed for the purposes of this Pact.

7. Fall Clause:

7.1 The BIDDER undertakes that it has not supplied/is not supplying similar product/systems or subsystems at a price lower than that offered in the present bid in respect of any other Ministry / Department of the Government of India or PSU and if it is found at any stage that similar product/system or sub-system was supplied by the BIDDER to any other Ministry/Department of the Government of India or PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded.

8. Independent monitors:

8.1 The BUYER has designated the CVO of IIT Bombay as the authority to monitor all the procurement processes independently and objectively.

9. Facilitation of Investigation In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information & documents in English and shall extend all possible help for the purpose of such examination.

10. Law and Place of Jurisdiction This Pact is subject to Indian Law. The place of performance and Jurisdiction is the Seat of the BUYER.

11. Other Legal Actions The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

12. Validity:

12.1 The validity of this Integrity Pact shall be from date of its signing and extend up to 5 years or the complete execution of the contract to the satisfaction of both the BUYER and the BIDDER/ Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.

12.2 Should one or several provisions of this Pact turn out to be invalid, the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions. The Parties hereby sign this Integrity Pact.
