## **Terms and Conditions**

## 1. Customer References

The supplier shall provide documented feedback from at least three government institutions that are existing users of the proposed software.

The supplier must have successfully installed similar or higher-configuration software at a minimum of three (3) sites within India and must provide contact details of the respective clients for verification.

#### 2. Training & Documentation

- The supplier shall provide comprehensive hands-on training to all engineers' postinstallation. Training must cover all core functionalities of the software.
- o Training certificates must be issued for at least 10 personnel.
- Onboarding documentation and three sets of user manuals (in English) must be supplied with the software.

#### 3. Installation & Delivery

- The supplier shall be responsible for the complete installation and commissioning of the system.
- The license key & server must be delivered within four (4) weeks from the date of the purchase order.

### 4. Warranty & Support

- A comprehensive warranty covering both hardware and software components shall be provided for a period of three (3) years from the date of commissioning.
- Free software updates, including version upgrades, patches, and bug fixes, shall be provided for three (3) years post-commissioning.
- Technical support for a period of three (3) years must also be provided, covering troubleshooting, maintenance, and performance optimization.

# 5. Extended Support

- Support for reinstallation or migration in case of hardware changes shall be provided for up to five (5) years at no additional cost.
- o Perpetual research license support must be ensured for a period of three (3) years.

#### 6. Timeline

The supplier shall complete the supply, installation, training, and commissioning within 10 to 15 days from the date of delivery.

## 7. Payment Terms

100% payment shall be released upon delivery by the funding agency on behalf of IIT Bombay.
